Hospitality offers a range of both entry level jobs and career progression opportunities. To get you job ready, you'll learn about areas of health and wellbeing and personal development, how to use workplace technology and business systems and responsible service of alcohol (RSA). This training also includes infection prevention and control procedures and food safety.

## Eligibility criteria

Students who meet one or more of the following eligibility requirements will be eligible for fee free (course and resource fee) training.

Eligibility requirements	Evidence of eligibility
Persons aged 15–24 years at the time of enrolment (excluding school students).	» Present current driver's license, birth certificate or similar.
Persons and dependants of persons receiving JobKeeper payments.	» A statutory declaration from an employer confirming they are in receipt of JobKeeper payments for the student.
Persons and dependants of persons receiving the Youth Allowance, AUSTUDY or ABSTUDY.	» Evidence or advice from Centrelink.
Persons and dependants of persons holding: » a Pensioner Concession Card; » a Health Care Card; or » a Repatriation Health Benefits Card issued by the Department of Veterans' Affairs.	» Present valid card.
Persons and dependants of persons in receipt of services from the following Commonwealth support or employment services programs: » Jobactive; » Online Employment Services; or » ParentsNext.	» A letter from the Commonwealth services provider confirming the student's participation in the program.
Dependants of persons who are inmates of a custodial institution.	» Present evidence to show that the student is the dependant of an inmate and identify the relationship between the two.

Students who do not meet one or more of the criteria listed above are able to enrol in the skill sets and pay the applicable course and resource fees in accordance with the Department of Training and Workforce Development's current Fees and Charges Policy, available at [dtwd.wa.gov.au](http://dtwd.wa.gov.au).
